Welcome to the 2024-2025 dance season at Artistic Motion! We are looking forward to welcoming new and existing members to the Artistic Motion family. Please read <u>all</u> the information below carefully, as there are <u>important dates</u> to put in your calendar for this year.

As always, we are very proud of our faculty and thankful to them for putting their hearts and minds into the development of our studio. Artistic Motion's most important goal is to provide the absolute highest quality of teaching in order to enable our students to achieve their greatest aspirations in the performing arts.

FEES and Family Discounts

- The Annual **Registration Fee** is discounted by 50% for Registrations received before August 26, 2024.
- After August 26, 2022, Administrative Fee is \$40.00 (first child) and \$20.00 (each additional child in family) and due with online registration.
 A \$60.00 Performance Fee (First child/ \$30.00 second child in family) will be due with the second semester registration for all performers
- participating in the Spring Recital/Production.
- Tuition fees are posted monthly and due by the 10th of the month.
- Family discounts will be applied to monthly tuition as follows:
 - ~ 6-7 total hours in the studio = 20% discount; 8 + total hours in the studio = 30% discount
 - ~ Individual students registered for 10+ class hours and Artistic Motion Dance Company may attend additional classes at no charge.
 - ~ Triad Ballet School, Voice, Piano, and Company Class are not subject to any discount.

There are three options for payment:

*Payment for year in full upon registration, <u>OR</u>

*Two Semester payments due August 29, 2022, and January 21, 2023, OR

* Monthly payments due by the 10th of each month.

<u>NOTE</u>: A <u>Late Fee</u> of \$25.00 will be added to your account if payment is made past the 15^{th} of the month, or if online payment is declined. <u>Returned Check Fee</u> is \$25.00.

**All accounts must be kept current within 30 days, or the Director of Artistic Motion reserves the right to suspend the student from the program until the account is paid in full. Please make all checks payable to: <u>Artistic Motion</u>.

***Please remember to enter <u>CREDIT CARD</u> information when registering. WE ARE NOT ABLE TO ACCEPT CHECK DRAFTS AT THIS TIME. Please do not enter checking account routing/account numbers for payment information.

DANCE COMPANY: <u>The Artistic Motion Dance Company is planning to hold auditions Saturday, September 7th, from 1:00-3:00, with the annual town hall meeting to follow 3:00-4:30, for prospective members ages 9 – Adult with previous dance experience. Returning members are also required to audition.</u>

*AM Dance Company Members must commit to attend all Company rehearsals as well as sign a contract for the year.

*Please note all AM Dance Company members are required to take 2 Ballet classes a week. Dancers do not have to be Artistic Motion students to participate in AM Dance Company.

*Company Dancers and any additional participating dancers will have a \$60.00 performance fee per production.

*Parents of AM Company participants will have a volunteer commitment for each production.

***The Director reserves the right to suspend a company member with more than 2 unexcused absences from a performance. ***
